## Types of Initiatives



- \* **New Program or Service**
- \* **Clearly Defined Expansion** – significantly increasing population served, broadening the offering to a different population, broadening type of service offered, or improving effectiveness with improved outcomes

# Initiative Impact



- ✧ Addresses a need
- ✧ Demonstrates measurable results
- ✧ Broadly and/or deeply benefits community or population served
- ✧ Explains how the actions taken will lead to impact
- ✧ Describes how much will change, how deep is the change, for how many and for how long

## Eligible Organizations



- \* Defined as tax-exempt public charity under Section 501 (c) 3
- \* Registered as nonprofit corporations with FL Dept of State and FL Dept of Agriculture & Consumer Services unless exempt
- \* Been in operations minimum of 24 months and be able to provide financial statements and tax returns for this period
- \* Willing to disclose any pending legal action
- \* If collaborating with another organization, both satisfy guidelines

## Eligible Initiatives



- \* **Clearly Defined** – the need, the budget and the initiative itself are clear
- \* **Viable** – the steps to successfully implement the initiative are well thought-out and explained
- \* **Sustainable** – the steps to sustain the initiative and its benefits beyond the 24-month grant period are described well
- \* Designed to Achieve **High Impact** – the described impact demonstrates measurable results and the broad and/or deep benefit for the community or population served






## Eligible Initiatives



- ✧ **Primarily serve and benefit Sarasota and Manatee Counties**
- ✧ **Initiative activities and funding fall within the 24-month grant period**
- ✧ **Initiative budget is equal to or greater than the Impact100 SRQ grant**
- ✧ **Initiative budget allocated to Impact100 SRQ is equal to grant amount**

## Eligible Initiatives

**Designated by Applicant for one of five focus areas**

-  **Arts, Culture & History**
-  **Education**
-  **Environment, Recreation and Animal Welfare**
-  **Family**
-  **Health & Wellness**
